Peddler/Itinerant Vendor Permits

No person shall act as a peddler, hawker, itinerant vendor or mobile food vendor, within the City of Uvalde without first obtaining a permit in accordance with this ordinance.

Definitions:

Peddlers go from door to door or house to house without a prior invitation to sell a product or service. They must pass a background check.

Itinerant vendors set up a temporary business on private property. They must have permission from the property owner where they intend to operate.

Mobile food vendors "hot" cook and sell food on private property. They must obtain appropriate health certificates from the state health department, and have proof of insurance for vehicles that they use, and a valid driver's license, as well as permission from the property owner where they will be operating.

Mobile food vendors "cold" sell prepackaged food from a vehicle that travels on public streets, stopping for no more than 15 minutes when requested of residents. They must obtain appropriate health certificates from the state health department, have proof of insurance and valid driver's license for motorized vehicles, and pass a background check.

Seasonal vendors are itinerant vendors who operate for one week before and including the following holidays: high school homecoming, Valentine's Day, Easter, Mother's Day, Father's Day, Veteran's Day, All Saints Day, and Christmas. They must have permission from the property owner where they intend to set up business.

Agricultural product vendors sell products that are typically raised or produced on farms.

Fees:

Peddler - \$100 for 6 months, plus \$15.00 per sales representative, renewal \$75.00

Itinerant Vendor - \$100 for 1 year, renewal \$75.00

Seasonal Vendor - \$15 for one week, non-renewable

Agricultural Products Vendor - \$25.00 for one year, \$25.00 renewal

Mobile Food Vendor Hot - \$150.00 for one year, \$115 renewal

Mobile Food Vendor Cold - \$30 for 6 months, \$20 renewal

Rules:

1. You may not behave in an aggressive manner by making physical contact, using abusive language, following the potential customer, blocking their way, or continuing to press them for a sale after they have given a negative response.
2. You may not block streets, alleys, driveways or sidewalks or block the view of traffic. Locate your business at least 25 feet from intersections of alleys, driveways and streets.
3. You must display your tax ID, vendor's permit and health certificate if applicable.
4. Peddlers may sell from 30 minutes after sunrise to 30 minutes before sunset.
5. You may not sell if the property owner has posted signs such as "No Trespassing" or "No Solicitors."
6. Peddlers need to have a photo ID prominently displayed.

Name-based information is not an exact search and only fingerprint record searches represent true identification to criminal history record information (CHRI), therefore the organization conducting the criminal history check is not allowed to discuss with me any CHRI obtained using the name and DOB method. The agency may request that I also have a fingerprint search performed to clear any misidentification based on the result of the name and DOB search.

In order to complete the fingerprint process I must make an appointment with the Fingerprint Applicant Services of Texas (FAST) as instructed online at [www.txdps.state.tx.us /Crime Records/Review of Personal Criminal History](http://www.txdps.state.tx.us/CrimeRecords/ReviewofPersonalCriminalHistory) or by calling the DPS Program Vendor at 1-888-467-2080, submit a full and complete set of fingerprints, request a copy be sent to the agency listed below, and pay a fee of \$25.00 to the fingerprinting services company.

Once this process is completed the information on my fingerprint criminal history record may be discussed with me.
