Agenda Item No. 6 – Public Hearing & Zoning Matters

6A. Open a public hearing on the request of Jose Manuel Ramos, applicant, Case File 20-15PZ to apply for a Special Use Permit to allow applicant to sell alcohol beverages in a Business 3 zone. The property is located at 226 North Getty Street, NCB 43, Old Town Subdivision, Block 12, Lot 175, 176, City of Uvalde, Uvalde County Texas.

The City of Uvalde opened the public hearing on Agenda Item 6A at 6:02 p.m.

Jose Manuel Ramos, applicant, addressed City Council about his ideas and plans for the restaurant and bar, known as "The Huddle". He is the new tenant taking over the establishment. He has received approval for the liquor license from Texas Alcohol Beverage Control Commission (TABC) and hopes to open for business by the end of the July. Due to a city ordinance and zoning restrictions in the Uvalde Municipal Code, Mr. Ramos needs approval for permission to sell alcohol at 226 North Getty Street.

The City of Uvalde closed the public hearing on Agenda Item 6A at 6:05 p.m.

Agenda Item No. 7 – New Business

7A. Consider and act on the request of Jose Manuel Ramos, applicant, Case File 20-15PZ to apply for a Special Use Permit to allow applicant to sell alcohol beverages in a Business 3 zone. The property is located at 226 North Getty Street, NCB 43, Old Town Subdivision, Block 12, Lot 175, 176, City of Uvalde, Uvalde County Texas.

Motion made by Mayor Pro Tem Rogelio Munoz to approve Agenda Item 7A. Councilman Chip King seconded the Motion. Motion carried 5-0.

7B. Consider and act on renewing contract with Linebarger Goggan Blair & Sampson, LLC.

Motion made by Councilman Stephen E. Balke to table Agenda Item 7B until City Council receives a recommendation or report from Municipal Court Judge Andrew W. Hagen regarding the services provided by Linebarger. Motion was seconded by Mayor Pro Tem Rogelio Munoz. Motion carried 5-0.

7C. Consider and act on Ordinance Amending Chapter 18 of the Uvalde Municipal Code for Historic Preservation Chapters 18.01.040 and 18.01.160.

Vince DiPiazza, City Manager, explained to City Council that this ordinance came about as a result of a request from Mayor Pro Tem Rogelio Munoz. The amendment to this ordinance will allow the Planning Director/Historic Preservation Officer to administratively approve signage applications to avoid business owners having to wait a month, or more if there is not a quorum, to have their signage approved. In addition, this ordinance removes the \$50 application fee only for new Certificates of Appropriateness. Motion by Councilman Stephen E. Balke to approve Agenda Item 7C. Motion was seconded by Mayor Pro Tem Rogelio Munoz. Motion carried 5-0.

Agenda Item No. 8 - Report

- 8A. Report by Debra Stifflemire, Executive Director of the Uvalde Convention & Visitors Bureau for the 2nd Quarter 2015.

 Debra Stifflemire, Executive Director of the Uvalde Convention & Visitors Bureau presented to Council the 2ndQuarter 2015 Profit & Loss Budget, Balance Sheet, & Profit and Loss Statement to Council. Total Income for the quarter was \$73,811.63 with total expenses being 66,066.50 leaving a net ordinary income of 7,745.13.
- 8B. Report by Kasie Morgan, Civic Center Manager on the (January March) 2nd Quarter 2015 activities.

 Kasie Morgan, Civic Center Manager, reported to Council the 2nd Quarter 2015 activities. There were 17 income generating events, 62 non-income generating events and 1 City sponsored event giving a total of 80 events for the 2nd Quarter. Total rental fees for this quarter were \$16,580.00. Council members asked about the use of the Cactus Room by non-profits. Ms. Morgan explained that the rental of the Cactus Room is free and is sometimes not left in great condition after use. There was some discussion by Council about possibly requesting a refundable rental deposit for the use of the room or limiting the rental of the room to 5 free uses before a nominal charge was implemented. Council tasked Ms. Morgan and

Mrs. Stifflemire to come up with some proposals for the use of the room for Council to discuss at a future meeting.

Agenda Item No. 9 – Council Discussion

9A. Discussion by Councilman Chip King in regards to the water fountain located on the downtown plaza.

Councilman Chip King reported that at a recent Finance Committee meeting the subject of beautification of the fountain on the down town green was discussed. Councilman King has drawings from John Graves that date back to 1961. At that time it cost \$12,000 to build the fountain which was funded mainly by private citizens with the agreement that the City would maintain the fountain. That lasted for about 10 plus years until there was some damage to the inner workings of the fountain. As a result, the fountain was filled in and is no longer operational. Councilman King would like to stimulate some community interest in restoring the original fountain with colored lights to its original state. Councilman King has spoken with Vic Hilderbran about possibly using some of the Eagle Scouts to take on the project to help restore the fountain. Mayor and Council members agreed with Councilman King and urged him to pursue ideas on means to having the restoration of the fountain commence.

9B. Discussion concerning possible annexation of 1008 South Getty Street, Abstract 31, Survey 70, owned by B & SE Properties, LLC. City Manager, Vince DiPiazza, informed City Council that he had received a letter requesting annexation from the property owner, Ben Elliott. It is a contiguous lot with a portion of the tract of land residing within the County of Uvalde. The frontage of the property that lies on FM 117 is within the City limits. There is no problem delivering City water and sewer services to the property. If the property were annexed the entire parcel would be subject to R-1 zoning restrictions. City Council directed staff to proceed with negotiations for annexation.
