

ORDINANCE 2013- 11

AN ORDINANCE OF THE CITY OF UVALDE, TEXAS ADOPTING THE STATE OF TEXAS FIRE MARSHAL INSPECTION FEE SCHEDULE FOR SERVICES PROVIDED WITHIN UVALDE COUNTY AND OUTSIDE UVALDE COUNTY

WHEREAS, pursuant to §2.20 of the Uvalde Municipal Code, the Fire Marshal for the City of Uvalde, in the execution of his duties as Fire Marshal, conducts Fire and Safety Inspections for residential and local businesses, private prisons and jails, conducts inspections for fire-extinguishing systems and fire-alarm systems, reviews fire protection plans, and visits public K-12 schools for educational purposes.

WHEREAS, the Fire Marshal often travels out of the County of Uvalde to perform inspections and educational services to neighboring cities that do not have a Fire Marshal.

WHEREAS, the City of Uvalde pays the salary, related training and educational expenses for its Fire Marshal. Neighboring cities benefit from the services and knowledge from the City of Uvalde's Fire Marshal when he travels out of County to conduct inspections.

WHEREAS, related expenses, mileage and fees for out-of-county inspections and services provided by the City of Uvalde Fire Marshal are costly to the City of Uvalde.


WHEREAS, the City of Uvalde desires to adopt into its Code of Ordinances the a Standard Fire Marshal Fee Inspection Schedule for services provide within Uvalde County and Outside Uvalde County for services performed by its Fire Marshal.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF UVALDE, TEXAS:

SECTION 2.20.110 The attached Inspection Fees be adopted for services performed by the City of Uvalde Fire Marshal for inside and outside the County of Uvalde. The fees resulting from this Ordinance are hereby determined to be just and reasonable rates to be observed and in force within the City and County of Uvalde and outside the County of Uvalde.
