

ORDINANCE 2017-03

AN ORDINANCE OF THE CITY OF UVALDE, TEXAS REPEALING ORDINANCE 2016-05 WHICH AMENDED CHAPTER 10.24 OF THE CODE OF ORDINANCES ADDING SECTIONS 10.24.020 AND 10.24.030 PERTAINING TO STOP SIGNS ON WEST OPPENHEIMER STREET AND RELATED MATTERS

WHEREAS, after a traffic investigation the City Council adopted Ordinance 2016-05 adding stop signs to create a four-way stop at the intersection of W. Oppenheimer St. and N. Park St. and three-way stops at the intersections of W. Oppenheimer St. with Bowie St. and Mackenzie St.; and

WHEREAS, after further traffic investigation, the City Council finds that the additional stop signs at the above referenced intersections have not had the intended effect of improving traffic safety at those intersections; and

WHEREAS, Texas Transportation Code Section 542.201 provides that a local authority may regulate traffic in a manner that does not conflict with Texas Transportation Code Chapter 542, Title 7, Subtitle C; and

WHEREAS, the City of Uvalde, Texas (herein the "City"), has the authority to adopt regulations regulating the direction and flow of traffic on streets located within the city limits;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF UVALDE, TEXAS:

Section 1. Adoption of Findings of Fact. The findings and recitations set out in this Ordinance are found to be true and correct and they are hereby adopted by the City Council and made a part hereof for all purposes as findings of fact.

Section 2. Repeal of Ordinance 2016-05 and Amendment of Chapter 10.24 of the Uvalde Municipal Code of Ordinances. Ordinance 2016-05 is hereby repealed and Sections 10.24.020 and 10.24.030 are hereby removed from the Code of Ordinances of the City.

Section 3. Conflicting Ordinances. All prior ordinances of the City dealing with stop intersections in said location are hereby amended to the extent of any conflict herewith, and all ordinances or parts thereof conflicting or inconsistent with the provisions of this ordinance as adopted and amended herein, are hereby amended to the extent of such conflict. In the event of a conflict or inconsistency between this ordinance and any other code or ordinance of the City, the terms and provisions of this ordinance shall govern.


Section 4. Severability. If any provision of this Ordinance or the application of any provision to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications hereof which can be given effect without the invalid provision or

application, and to this end the provisions of this Ordinance are declared to be severable.

Section 5. Effective Date. This Ordinance shall take effect immediately upon its adoption by the City Council and publication as required by the Local Government Code.
